Thank you to all those who have attended the parent activity sessions in class. They have been run by Lorna from WaterShed and have been all about how we are hoping to start harvesting our rainwater and the ways in which the children are going to be involved. #### **Free School Meals**

All children in Reception, Year 1 and Year 2 at state schools in England automatically get free school meals. However, from year 3 onward, children whose parents are getting any of the following are entitled to free school meals:

Universal Credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings from up to three of your most recent assessment periods).

Income Support (IS).

Income-based Jobseekers Allowance (IBSJA).

Income-related Employment and Support Allowance (IRESA).

The guaranteed element of State Pension Credit.

Support under Part VI of the Immigration and Asylum Act 1999.

Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income as assessed by Her Majesty's Revenue and Customs that does not exceed £16,190).

Working Tax Credit run-on (the payment you get for a further 4 weeks after you stop qualifying for Working Tax Credit).

How to apply:

Apply through the Citizen Portal - you will find this link at the bottom of our school website. This is the quickest and easiest way to apply and will result in you getting an instant decision. Alternatively, call the Education Helpline on 0345 155 1019 and they can process it.
